5 3. The deadline for Plaintiff to file the declaration of completion described in the June 9, 2026 Order
6 is extended to and including September 22, 2026.

7 4. The deadline for Plaintiff to file the motion for class certification, currently July 28, 2026, is
8 continued by sixty (60) days, to and including September 29, 2026.

9 5. The Case Management Conference currently set for July 28, 2026 are continued to
10 October 22, 2026, at 9:00 a.m. in Department CX103.

11 6. The Default Prove-Up Hearing currently set for July 28, 2026, which will only go forward if
12 Plaintiff were to dismiss the class action allegations and file for individual default judgment, is
13 continued to October 22, 2026, at 9:00 a.m. in Department CX103.

14 7. Except as modified by this Order, the June 9, 2026 Order remains in full force and effect, and the
15 Court retains jurisdiction to address any issues arising from its implementation.
